BLACK BEAR WOMEN'S LEAGUE

The Black Bear Women's Golf League is open to all woman of all abilities. League matches provide Black Bear Golfers the opportunity to meet and compete in an atmosphere of friendly competition at one of Minnesota's premier championship golf courses.

Women form a season long team of two players. Each team competes against another assigned team each week. Specific rules for play will be distributed upon registration or request. Points accumulate over the season and a League Champion is determined by a Match Play tournament at the end of the season. Teams are ranked upon their position in the final point standings.

League Fees:

- \$50 per player or \$100/team.
- \$40 Women's Club Fee (per player).

Weekly Fees:

- Greens Fees: \$20
- Cart Fees: \$10
(Waived if season pass holder)

Sub Fees:

- One time fee of \$15. Plus club fee.
- Allows you to sub each week.
- Subject to weekly fees.
